# What is this product?

The Fund is a UCITS and a sub-fund of Carnegie Investment Fund ("CIF"), an investment company with variable share capital (SICAV) organized as an umbrella fund governed by Luxembourg law.

#### Term


The Fund is open-ended but may, at any time, be dissolved by decision of the shareholder's meeting. For more information about this, see the Prospectus of the Fund

#### Objectives

The Fund aims to achieve long-term returns at least in line with the performance of the Stockholm stock exchange. To achieve this, the Fund invests at least 80% of its assets in equities and equityrelated instruments in Swedish Companies. The investment manager has full discretion on deciding what equities to invest in without any reference to a benchmark and selection is made based on an analysis of the expected return relative to risk, both short term and long term. The Fund may also invest in other transferable securities, money market instruments, fund units and other investments with equity-like characteristics. In order to make management more efficient, the Fund can also invest in derivative instruments, both long and short, both to protect (hedge) and to take active market risk and may as well enter into securities lending transactions to improve performance and generate

#### Intended Retail Investor

The Fund may be suitable for retail investors planning to keep the investment for 5 years and who understand that the money invested in the Fund can both increase and decrease in value and that they may not get back the full amount invested. Investors should have a basic knowledge and/or experience of UCITS funds and financial markets.

Shareholders are entitled to convert their shares in the Fund for shares in another sub-fund of CIF. Information about conversions can be found in the prospectus of the Fund. We have classified this product as 4 out of 7, which is a medium risk class.

#### **Performance Scenarios**

# What happens if Carnegie Investment Fund is unable to pay out?

However, this risk is mitigated by the fact that the Depositary s required by law and regulation to segregate its own assets from the assets of the Fund.

# What are the costs?

#### Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest and how long you hold the product. We have assumed:

- In the first year, you would get back the amount that you invested (0 % annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario.

# How long should I hold it and can I take money out early?

#### **Recommended holding period: 5 years**

The Fund has no minimum holding period but as it invests in equities it is suitable for investors with a medium to long-term investment horizon. Investors should be prepared to hold the fund shares at least until the end of the recommended holding period. The Fund is normally open for subscriptions and redemptions any day on which banks are open for business in Luxembourg, other than 24 December.
